- 6. Election of Permanent Secretary (Floor open to Nominations)
 Tom Benedetto was nominated with a second to the motion and endorsed
- 7. Appointment of Parliamentarian
 James McLaughlin was appointed Parliamentarian by Chairman Cunningham
- 8. Nominations from the floor Nominations for First Selectman were requested. Karen McWhirt nominated Paul Zulpa. Sandra Hoey gave a second nomination Claudette Volage nominated Joel Serota. Dan Trella gave a second nomination No further nominations were provided.

Motion by Robert Scott for paper ballots pursuant to CGS 9-396 to be held for the office of First Selectman Motion accepted by majority of raised hands. No hand counting was needed.

Question on the floor was asked if nominees for First Selectman speak before the voting takes place? Chair Cunningham asked Parliamentarian if First Selectman nominees speak before paper ballot votes counted?

Parliamentarian replied that the next action is to vote.

Chair Cunningham confirmed to the floor that the vote needs to take place.

Paper Ballots were distributed and voters asked if everyone received a ballot. All voters received a paper ballot.

101 voters were counted in attendance.

Paper Ballot Count Summary: 91 ballots received, 1 abstain.

Paul Zulpa received 88 votes, Joel Serota received 12 votes.

Paul Zulpa was endorsed by the caucus for the office of the First Selectman. Paul Zulpa provided his acceptance speech.

First Selectman, Barbara Perkinson, nominated Karen Reddington-Hughes for the Board of Selectmen. A second motion was provided.

No further nominations were provided

Chair Cunningham announced the (16) open position elections, all nominations received second motions. All nominations were endorsed by general consent.
